The Oregon referendum, sponsored by the Oregon Citizen's Alliance, further mandated that: all government agencies and schools recognize homosexuality as "abnormal, wrong, unnatural and perverse" and no government money or properties could be used to "facilitate" homosexuality. This is the story of what happened in Oregon.]**

So, I'm walking out of city hall, and this woman yells and comes running up to me, "Hey Kathleen, I'll hug you!" and she gave me this great big hug. And I went place after place where people came and said, "I'll hug you! "

Once upon a time there were a group of people who had special rights; they were white men who owned land. And over time they've been pressured to extend those same rights, which were at some point in time "special rights," to other people . So maybe they DO think they're special rights for a

woman to get equal pay, or for there to be some real competition for a person of color, or for a lesbian or gay person to be able to rent a place. Maybe they do think they're special, I don't--I think they're equal rights. "Special rights" is applied whenever the in-group doesn't want the out-group inside.

The minority status was created for black people because they could not function equally in society, so we created those minority benefits on that basis.

There was never any intention to have an affirmative action program for gays and lesbians. I am the past director of affirmative action for the state of Oregon, and the language being used here is the politics of confusion. Because lesbians and gay men have said "we want equal rights", there is this counter argument that those are "special rights." All that lesbians and gays have asked for is nondiscrimination in the area of housing, employment and public accommodation. Whether you believe it's okay to be lesbian or gay is not the issue. Should we amend the constitution to discriminate against a group of people? No.

There can be no justice when we single out any group of citizens and decide that there must be special laws to deprive them of their rights. That is propaganda, designed for divisiveness. As a national official, what really frightens me--where does this go if indeed there is success here?

The oppression and the effects of the oppression of gay/lesbian people and of African heritage folk, they are different--but yet the tool of oppression is the same. Oppression is the systematic mistreatment of human beings. So I knew what I needed to do was to talk about how the oppressions were linked, how one validated the other. We are trained to be bigots, we are trained to be homophobic. I knew that I needed to work in those places where I was "assigned" the role of the oppressor; if I wanted white people to stop practicing racism, I had to stop practicing homophobia.

I remember growing up and hearing the words, feeling the sting of names like "nip" "jap," "chink" "slant eye" "gook", "f-o-b"-- they were mere words, but words which carried real consequences in a country that allowed slavery, genocide and segregation to occur within its borders. I understand that the twisted logic and language of bigotry rendered Asian immigrants less than human, and subject to exclusionary policies, mob violence and discrimination. I understand that the dehumanization of Japanese-Americans, partly through language, paved the way for the World War II imprisonment of



120,000 Japanese-Americans in concentration camps. Ballot Measure 9 is a 1990's version of the same twisted language and logic of bigotry.
